Management's Responsibility for the Financial Statements:

Emphasis of Matter:

- i. Cash book was maintained in computer.
- ii. Fixed Assets Register was maintained in computer.
- iii. The payment of net Salary to the Teaching and Non-Teaching employees (after deduction on account of Income Tax, PF and other deductions made from the Gross Salary of the employees) of the College was made by the University directly to the employees' Bank Account. However after obtaining the details of such deductions, the college has given accounting effect of those deductions in its books and accordingly account prepared.

Our opinion is not qualified in respect of the above matter.

Report on Other Matters:

We further report that

- i. we have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit;
- ii. in our opinion Books of account required by law have been kept by the organization so far as appears from our examination of the book; and,
- iii. the Receipt & Payment Account dealt with by this report is in agreement with the books of account.

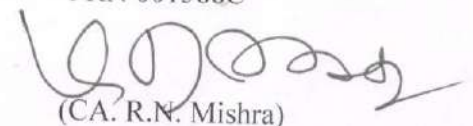

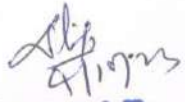

- ii. in our opinion Books of account required by law have been kept by the organization so far as appears from our examination of the book; and,

The details of such payment is not known to the College nor the accountal effect of the same is given in the financial books of the account the College.

Our opinion is not qualified in respect of the above matter.

Report on Other Matters:

We further report that

- i. we have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit;
- ii. in our opinion Books of account required by law have been kept by the organization so far as appears from our examination of the book; and,
- iii. the Receipt & Payment Account dealt with by this report is in agreement with the books of account.
